We need California Licensed Professional Geologists to take a 3 hour examination with an additional hour of instruction time (total 4 hours) at any Prometric Testing Center throughout the state of California.

The sole purpose of this “Field Test” is to determine the viability and relevance of test questions used to set the minimum standard for licensure in California.

You will be recognized by the Board for your efforts to assist the profession, and will receive \$128 for your time, and be reimbursed \$0.565 per mile for travel to and from the test site.

You must register by December 13, 2013 to take the examination per your own schedule January 6-17, 2014.
