PROPOSED DECISION

Administrative Law Judge Vallera J. Johnson, State of California, Office of Administrative Hearings, heard this matter in San Bernardino, California, on November 18 and 19, 2013.

Sydney M. Mehringer, Deputy Attorney General, represented Complainant Robert B. Moore, Executive Officer of the Board of Professional Engineers, Land Surveyors and Geologists, Department of Consumer Affairs.

John H. Belton, Esq., represented Respondent Paul Christopher Ehe, who was present during the hearing.

The matter was submitted on December 27, 2013.1

FACTUAL FINDINGS

1. Richard B. Moore, PLS (Complainant) filed Accusation, Case No. 1037-A, in his official capacity as the Executive Officer of the Board for Professional Engineers, Land

Surveyors, and Geologists (Board), Department of Consumer Affairs. Paul Christopher Ehe (Respondent) filed a Notice of Defense in a timely manner and requested a hearing in this matter.

- 2. On April 22, 1983, the Board issued Land Surveyor License Number L 5280 (License) to Respondent. At all times relevant herein, said License was in full force and effect.
- 3. Complainant seeks discipline of Respondent's License on grounds that: (1) Respondent failed to file 41 Records of Survey and 103 Corner Records with the San Bernardino County Surveyor (County Surveyor) in a timely manner; (2) this conduct constitutes negligence; and (3) the Board has previously disciplined Respondent. Respondent did not dispute that he was responsible for untimely filings, explained the reasons that he failed to file various surveys and corner records in a timely fashion, and provided reasons he should be allowed to retain his license.

Significance of Recording

4. Land title interests in California are conveyed and held through the Recording Act process. Deeds, mortgages, records of survey and other land title documents are recorded in the County Records. The recording of these documents serves to establish, perpetuate, clarify and refine chains of title to real property. The recording process gives "notice to the world" as to who has what rights to which lands. Buyers purchase property based upon these records. Title companies warrant titles based upon them. Mortgages are backed by collateral documented in the County records. Landowners occupy real property and invest and work the land secure in the knowledge that their title interests are being protected through the Recording Act process. When disputes arise and/or there is ambiguity in the record, courts quiet title with deference to the public record.

When relevant documents are not recorded, ownership interests may become clouded. Buyers may not know what they are buying. Appraisers may not know what they are appraising. Title companies may not know what they are warranting title to and against what risks. Lenders may hesitate to enter into mortgages secured by indeterminate collateral. Property owners hesitate to invest in their property and make full use of it. The system breaks down.

Land Surveyors file Records of Survey and Corner Records with the County Surveyor in compliance with Business and Professions Code section 8762.² Records of Survey and Corner Records compliment other recorded documents filed with the County Surveyor clarifying the true nature and extent of the record title interests.

² All statutory references are to the Business and Professions Code unless otherwise stated.

Surveyors constantly work to overcome surveying errors and the ravages of time. Individuals make mistakes. Geopositional accuracy was relatively approximate only a few decades ago. Monuments may be omitted or lost over time. Common Report, Rules of Construction, and other conventions serve to heal these vagaries. Recording Records of Survey and Corner Records expedites these upgrading processes. Various professionals are able to see what their peers and predecessors did and what they concluded. They may elect to reject these opinions or follow suit. Either way, the surveyor's work is easier to follow and assess when it has been properly documented and recorded as required by law.

The standard of care requires the competent land surveyor to document his surveys in accordance with Code section 8762. Doing so serves to settle boundaries and quiet litigation to the benefit of all property owners and the public at large.

Standard of Practice

5. A competent land surveyor begins each boundary survey with a contract that complies with Code section 8759 and the regulations governing the practice of land surveying. Boundary surveys entail office research and field surveys to ascertain the boundaries of a parcel of land and/or easement. Thereafter, the land surveyor issues an opinion. The land surveyor prepares and files appropriate documentation for his survey with the County Surveyor to begin the map checking process.

Pursuant to Code section 8762, the land surveyor must submit the Record of Survey to the County Surveyor within 90 days of completion of the field survey or setting pins, whichever occurs first. If the land surveyor cannot comply with the 90-day time limit for reasons beyond his control, he must notify the County Surveyor. Upon receipt of the Record of Survey, the County Surveyor must review it within 20 working days in accordance with Code section 8766, the County engineers association, and the County development standards. The competent land surveyor carefully considers the County Surveyor's input and must resubmit the Record of Survey within 60 days or within the time mutually agreed upon by the licensed surveyor and the County Surveyor.

The County Surveyor's Efforts to Process Older Files

6. Michael W. Raihle (Raihle) worked in the County Surveyor's office for 35 years, knew most of the surveyors in the San Bernardino County community, and had known Respondent since the 1980's. Raihle served as the San Bernardino County Surveyor for four years until his retirement in March 2012.

Raihle explained that between the 1990's and 2000's, there was a backlog in the County Surveyor's Office. There was an economic boom, and the County Surveyor's Office was inundated with maps. Private surveyors submitted numerous surveys, sometimes hundreds of them. The volume impacted the County Surveyor's ability to address the maps within 20 days. Private surveyors were aware that at times it took the County Surveyor's Office up to six months to return the maps.

- 7. In November and December 2002, William V. Scribner, a deputy for (then) County Surveyor Ken A. Smith, sent Respondent 10 reminder letters advising him that he had 10 outstanding Records of Survey. According to these letters, the Records of Survey had been last returned to Respondent on various dates between 2000 and 2002.
- 8. In 2009, there was an effort in the County Surveyor's Office to "clean up" some of the older files pertaining to unfinished Records of Survey and Corner Records that had remained stagnant for over a year. There were 50 surveyors who had outstanding projects, including Respondent. At that time, Respondent had 54 outstanding Records of Survey, the oldest from 1990. Respondent had 106 outstanding Corner Records, the oldest from 1998.

Raihle sent letters to Respondent, dated November 3, 2009, and May 18, 2010. The letters notified Respondent that there were surveys that had been returned to him for additions or corrections that had not been resubmitted; there was no correspondence on file, and Raihle was not aware of any reason for non-compliance. In response to the November letter, Respondent informed Raihle that he would provide a current status report for each survey and that he would become compliant as soon as possible. The second letter was sent because the County Surveyor had not received the estimated time frame for completion of surveys at issue from Respondent.

In November 2009, Respondent explained that he would provide a current status for each survey and that he wanted to become compliant as soon as possible. In an email, dated May 25, 2010, from Raihle to Respondent, Raihle expressed concern that he had not received an estimate of completion for the maps; further, during the prior seven months, of the 54 outstanding Records of Survey, Respondent had worked on five and had recorded just one.

By letter, dated June 7, 2010, Respondent addressed Raihle's letters and concerns. He explained that he was committed to completing the Records of Survey as soon as possible, but he had significant financial problems, including paying bills, paying his mortgage, and putting food on his family's table, that interfered with his ability to do so.

On March 17, 2011, Raihle filed a complaint with the Board. In his letter to the Board, Raihle explained the efforts his office had made to obtain completion of the maps. Among other things, he said that his office had made it clear to all surveyors that the County Surveyor's office was willing to cooperate with anyone who demonstrated that he was working toward completion of back projects and would continue to do so. However, there were several licensed surveyors who had not responded or had not completed their projects. Respondent's name was included among this list of surveyors.

Tom Herrin (Herrin), the current County Surveyor, testified that he has worked with Respondent to complete the maps; if Respondent continued working on the outstanding Records of Survey, he would not charge Respondent any additional money (above and beyond the original filing fee that Respondent paid years ago) to review these surveys.

Failure to Timely Resubmit Records of Survey

- 9. Respondent did not resubmit Records of Survey within 60 days of being returned by the County Surveyor for corrections regarding 41 Records of Survey. With many of these, there were multiple failures to timely resubmit.

Allegation of Negligence

- 11. Respondent stipulated to the truth of the facts set forth in Findings 9 and 10. Stated in the alternative, Respondent did not dispute that between 1992 and 2009, he failed to resubmit 41 Records of Survey within 60 days of being returned by the County Surveyor for correction; and, he did not dispute that between 1998 and 2009, he failed to resubmit 103 Corner Records within 60 days of being returned by the County Surveyor for correction.
- 12. In support of the allegation of negligence, Complainant offered the testimony of Patrick J. Minturn (Minturn), an expert witness.

Minturn obtained his bachelor's of science degree in civil and environmental engineering from Michigan State University, a master's of science degree in civil engineering from California State University – Los Angeles, and a master of public administration from National University (County Cohort).

Minturn is registered as a civil engineer and licensed as a land surveyor. Prior to this case, Minturn had reviewed 140 cases and testified in five cases on the Board's behalf. He had testified in one case on behalf of a respondent.

On the day of hearing, Minturn was the Director of the Shasta County Department of Public Works. For the last 12 years, Minturn has been the Shasta County Land Surveyor; for four years prior, he was the Deputy County Land Surveyor. In addition, he did work as a land surveyor while working for the Los Angeles County Department of Public Works, as well as working for the Michigan Department of Transportation.

Minturn is a member of the American Public Works Association, American Society of Civil Engineers, California Land Surveyors Association, and County Engineers Association of California.

Based on his education, training and experience, Minturn was familiar with the statutes and regulations that govern the practice of land surveying in the State of California.

- 13. Minturn established the facts set forth in Findings 4 and 5.
- 14. Expert testimony established that the standard of care requires the competent land surveyor to document his surveys in accordance with Code section 8762. This

documentation serves to settle boundaries and quiet litigation to the benefit of all property owners and the public at large.

15. Expert testimony established that Respondent was negligent in the practice of land surveying in that: (a) between 1992 and 2009, Respondent failed to complete the map checking process by failing to resubmit 41 Records of Survey within 60 days of being returned by the County Surveyor for correction; and (b) between 1998 and 2009, Respondent failed to complete the map checking processing by failing to submit 103 Corner records within 60 days of being returned by the County Surveyor for correction.

Respondent's Explanations

16. On the date of hearing, Respondent had been registered as a land surveyor for more than 30 years. He and his father co-founded a business known as Environmental High Tech Engineering, which was operational for 30 years. Respondent testified that, during that time, 7,000 varieties of surveys, 500 Records of Surveys, and thousands of Corner Records were performed. The majority of Environmental High Tech Engineering's business was conducted in San Bernardino County.

The community of surveyors in San Bernardino County is small, and the surveyors know each other. Respondent has known the last six County Surveyors, including the most recent County Surveyors, Raihle [the former County Surveyor], and Herrin [the current County Surveyor].

- 17. According to Respondent, there was a "mutual agreement" between private surveyors and the County Surveyor's Office that "time was not of the essence"; in other words, the timeframes set forth in applicable statutes were not enforced. Surveyors did not resubmit within 60 days, and the County Surveyor's Office did not return the documents to surveyors within 20 days. With the exception of Respondent's testimony, no evidence was offered to establish the existence this "mutual agreement" or its practice.
- 18. Respondent testified that he was committed to compliance, but financial hardships impaired his ability to do so. By the time of the hearing, the bank had foreclosed on his home; his truck had been repossessed, and he had been forced to terminate his employees.
- 19. Respondent made an effort to record the delinquent Records of Survey and to file delinquent Corner Records. As of the day of hearing, he had filed the outstanding Corner Records, and there were 10 Records of Survey that had not been filed.

Disciplinary Considerations

20. Effective September 25, 2000, in a disciplinary action entitled *In the Matter of the Accusation Against Paul Christopher Ehe*, Case No. 681-A, the Board revoked Respondent's License, stayed the revocation, and placed Respondent on probation for four

years on terms and conditions. The facts and circumstances underlying this earlier disciplinary action are that Respondent was negligent and incompetent in the practice of land surveying because, among other things, he filed 10 Corner Records when he should have recorded Records of Survey and incorrectly established a common line between two properties. Upon expiration of the probationary period, his License was fully restored.

On February 28, 2001, the Board issued Citation Order No. 5065-L to Respondent, ordering Respondent to cease and desist violating Code section 8780, subdivision (b), and to pay a fine of \$2,500 within 30 days of issuance of the Citation Order. On August 16, 2002, the Board issued Modified Citation Order No. 5065-L, reducing the fine to \$500. On July 29, 2004, the Board issued Second Modified Citation Order No. 5065-L. Complainant alleged that in the Second Modified Citation, the Board reduced the fine to \$250 and that Respondent paid the fine on August 21, 2004. No evidence was offered to establish the facts in the foregoing sentence.

Costs

21. Complainant seeks recovery of the reasonable costs of investigation and enforcement of this case. In support of the foregoing, Complainant offered (1) costs of investigation and enforcement (not including charges from the Attorney General's Office) for the expert witness in the amount of \$1,125; and (2) a Certification of Prosecution Costs: Declaration of Sydney Mehringer, Deputy Attorney General, in the amount of \$12,895.

LEGAL CONCLUSIONS

- 1. Section 118, subdivision (b), of the Code provides that suspension, expiration, surrender or cancellation of a license shall not deprive the Board of jurisdiction to proceed with a disciplinary action during the period within which the license may be renewed, restored, reissued or reinstated.
- 2. Section 8780 of the Code provides, in part, that upon receipt of a complaint, the Board may investigate the actions of any land surveyor licensed under Chapter 7 (commencing with Section 6700). By majority vote, the Board may publicly reprove, suspend for a period not to exceed two years, or revoke the license or certificate of any land surveyor licensed under Chapter 7 (commencing with Section 6700) who is legally authorized to practice land surveying on any of the following grounds:

 $[\P] \dots [\P]$

(b) Any negligence or incompetence in his or her practice of land surveying.

(d) Any violation of any provision of this chapter or of any other law relating to or involving the practice of land surveying. . . .

3. Section 8767 states:

If the county surveyor finds that the record of survey complies with the examination in Section 8766, the county surveyor shall endorse a statement on it of his or her examination, and shall present it to the county recorder for filing. Otherwise the county surveyor shall return it to the person who presented it, together with a written statement of the changes necessary to make it conform to the requirements of Section 8766. The licensed land surveyor or registered civil engineer submitting the record of survey may then make the agreed changes and note those matters which cannot be agreed upon in accordance with the provisions of Section 8768 and shall resubmit the record of survey within 60 days, or within the time as may be mutually agreed upon by the licensed surveyor or registered engineer and the county surveyor, to the county surveyor for filing pursuant to Section 8768.

4. Section 8773.2 states in part:

- (a) A "corner record" submitted to the county surveyor or engineer shall be examined by him or her for compliance with subdivision (d) of Section 8765 and Sections 8773, 8773.1, and 8773.4, endorsed with a statement of his or her examination, and filed with the county surveyor or returned to the submitting party within 20 working days after receipt.
- (b) In the event the submitted "corner record" fails to comply with the examination criteria of subdivision (a), the county surveyor or engineer shall return it to the person who submitted it together with a written statement of the changes necessary to make it conform to the requirements of subdivision (a). The licensed land surveyor or licensed civil engineer submitting the corner record may then make the agreed changes in compliance with subdivision (a) and note those matters that cannot be agreed upon in accordance with the provisions of subdivision (c), and shall resubmit the corner record within 60 days, or within the time as may be mutually agreed upon by the licensed land surveyor or licensed

civil engineer and the county surveyor, to the county surveyor for filing pursuant to subdivision (c). The county surveyor or engineer shall file the corner record within 10 working days after receipt of the resubmission.

(c) If the matters appearing on the corner record cannot be agreed upon by the licensed land surveyor or the licensed civil engineer and the county surveyor within 10 working days after the licensed land surveyor or licensed civil engineer resubmits and requests the corner record be filed without further change, an explanation of the differences shall be noted on the corner record and it shall be submitted to and filed by the county surveyor. The licensed land surveyor or licensed civil engineer filing the corner record shall attempt to reach agreement with the county surveyor regarding the language for the explanation of the differences. If they cannot agree on the language explaining the differences, then both shall add a notation on the corner record explaining the differences. The explanation of the differences shall be sufficiently specific to identify the factual basis for the differences....

5. Section 8762 states:

- (a) Except as provided in subdivision (b), after making a field survey in conformity with the practice of land surveying, with licensed surveyor or licensed civil engineer may file with the county surveyor in the county in which the field survey was made, a record of the survey.
- (b) Notwithstanding subdivision (a), after making a field survey in conformity with the practice of land surveying, the licensed land surveyor or licensed civil engineer shall file with the county surveyor in the county in which the field survey was made a record of the survey relating to land boundaries or property lines, if the field survey discloses any of the following:
 - (1) Material evidence or physical change, which in whole or in part does not appear on any

subdivision map, official map, or record of survey previously recorded or properly filed in the office of the county recorder or county surveying department, or map or survey record maintained by the Bureau of Land Management of the United States.

- (2) A material discrepancy with the information contained in any subdivision map, official map, or record of survey previously recorded or filed in the office of the county recorder or the county surveying department, or any map or survey record maintained by the Bureau of Land Management of the United States. For purposes of this subdivision, a "material discrepancy" is limited to a material discrepancy in the position of points or lines, or in dimensions.
- (3) Evidence that, by reasonable analysis, might result in materially alternate positions of lines or points, shown on any subdivision map, official map, or record of survey previously recorded or filed in the office of the county recorder or the county surveying department, or any map or survey record maintained by the Bureau of Land Management of the United States.
- (4) The location, relocation, establishment, reestablishment, or retracement of one or more points or lines not shown on any subdivision map, official map, or record of survey, the positions of which are not ascertainable from an inspection of the subdivision map, official map, or record of survey.
- (5) The points or lines set during the performance of a field survey of any parcel described in any deed or other instrument of title recorded in the county recorder's office are not shown on any subdivision map, official map, or record of

survey.

- (c) The record of survey required to be filed pursuant to this section shall be filed within 90 days after the setting of boundary monuments during the performance of a field survey or within 90 days after completion of a field survey, whichever occurs first.
- (d)(1) If the 90-day time limit contained in subdivision (c) cannot be complied with for reasons beyond the control of the licensed land surveyor or licensed civil engineer, the 90-day time period shall be extended until the time at which the reasons for delay are eliminated. If the licensed land surveyor ... cannot comply with the 90-day time limit, he or she shall, prior to the expiration of the 90-day time limit, provide the county surveyor with a letter stating that he or she is unable to comply. The letter shall provide an estimate of the date for completion of the record of survey, the reasons for the delay, and a general statement as to the location of the survey, including the assessor's parcel number or numbers.
 - (2) The licensed land surveyor or licensed civil engineer shall not initially be required to provide specific details of the survey. However, if other surveys at the same location are performed by others which may affect or be affected by the survey, the licensed land surveyor or ... shall then provide information requested by the county surveyor without unreasonable delay.
- (e) Any record of survey filed with the county surveyor shall, after being examined by him or her, be filed with the county recorder.
- (f) If the preparer of the record of survey provides a postage-paid, self-addressed envelope or postcard with the filing of the record of survey, the county recorder shall return the postage-paid, self-addressed envelope or postcard to the preparer of the record of survey with the filing data within 10 days of final filing. For the purposes of this subdivision, "filing data" includes the date, the book or volume, and the page at which the record of survey is filed with the county recorder.

- 6. Respondent is subject to disciplinary action under Code sections 8780, subdivision (d), and 8767 in that Respondent failed to resubmit 41 Records of Survey within 60 days of being returned by the San Bernardino County Surveyor for corrections.
- 7. Respondent is subject to disciplinary action under Code sections 8780, subdivision (d), and 8773.2, subdivision (b), in that Respondent failed to submit 103 Corner Records within 60 days of being returned by the County Surveyor for corrections.
- 8. Respondent is subject to disciplinary action under Code sections 8780, subdivision (a), 8762, 8767, and 8773.2, subdivision (b), in that Respondent was negligent in the practice of land surveying because (a) between 1992 and 2009, Respondent failed to resubmit 41 Records of Survey within 60 days of being returned by the County Surveyor for corrections; (b) between 1998 and 2009, Respondent failed to complete the map checking process by failing to resubmit 103 Corner Records within 60 days of being returned by the County Surveyor for correction.
- 9. Respondent asserted that the Board should be barred from filing the Accusation against him because there was an agreement between surveyors and the County Surveyor's Office regarding when Records of Survey and Corner Records were due. Respondent argued that in over 90 percent of the cases, the County Surveyor was late in returning the Records of Survey and Corner Records to Respondent. Because of this, Respondent argued that the County Surveyor had implicitly and explicitly represented that time was not of the essence so long as the work was done correctly. Further, Respondent contended that he relied on the County Surveyor's Office's implied representations and the unstated local procedures and practices.
- 10. Respondent offered no evidence to establish that there was an agreement between the County Surveyor's Office and private land surveyors. With the exception of Respondent's testimony, no evidence supported his argument. In fact, the evidence was to the contrary. The evidence established that the County Surveyor's Office made efforts to have Respondent and other surveyors file the required documentation with the County Surveyor.
- 11. Any delay by the County Surveyor's Office had no impact on Respondent's obligation to comply with the requirements that he resubmit his Records of Survey and file Corner Records in a timely manner.

If, in Respondent's opinion, the County Surveyor was taking too long to return maps to him, he had the option of requesting that the County Surveyor record his Records of Survey (Code section 8768³) and file his Corner Records (Code section 8773.2, subdivision

If the matters appearing on the record of survey cannot be agreed upon by the licensed land surveyor . . . and the county

³ Code section 8768 states:

(c) without making further changes. In addition, Code section 8768.5⁴ authorized Respondent and any other licensed surveyor to file an action against the County Surveyor if he failed to timely record the Record of Survey. No evidence was offered to establish that Respondent took advantage of these remedies.

Respondent argued that had he exercised any of the foregoing actions, he would have been blackballed. Respondent did not testify to the foregoing or offer any evidence in support of this argument.

By not availing himself of his options available under the Professional Land Surveyors' Act and by failing to object to the County Surveyor's Office's delays when they occurred, Respondent waived his right to object to the County Surveyor's delays.

12. The delays of the County Surveyor's Office were not unreasonable. The maximum delay in returning maps to Respondent was 10 months. On the other hand, the average time Respondent delayed in working on Records of Surveys was nine years, and his average delay in filing Corner Records was seven years. Given the discrepancy in time between how long it took the County Surveyor to return maps versus how long it took Respondent to resubmit his maps, the County Surveyor's delays were not unreasonable. In addition, former County Surveyor Raihle explained that the reason for the delay in the

surveyor within 10 working days after the licensed land surveyor . . . resubmits and requests the record of survey be filed without further change, an explanation of the differences shall be noted on the map and it shall be presented by the county surveyor to the county recorder for filing, and the county recorder shall file the record of survey. The licensed land surveyor . . . filing the record of survey shall attempt to reach agreement with the county surveyor regarding the language for the explanation of the differences. If they cannot agree on the language explaining the differences, then both shall add a notation on the record of survey explaining the differences. The explanation of the differences shall be sufficiently specific to identify the factual basis for the difference.

⁴ Code section 8768.5 states:

If the county surveyor fails to timely file the record of survey with the county recorder in accordance with Section 8768, the licensed land surveyor . . . submitting the map may bring an action pursuant to Section 1085 of the Code of Civil Procedure to compel the filing of the record of survey. After the licensed land surveyor . . . resubmits and requests the record of survey be filed without further change, the filing of the record of survey shall be deemed to be a ministerial act. . .

1990's and early 2000's was the economic boom. This sufficiently explained why the County Surveyor's Office was not always able to meet its own deadline.

Respondent offered no evidence to establish that the County Surveyor's delay caused him prejudice. The County Surveyor's delay in returning the maps did not impact Respondent's obligation to timely resubmit his surveys.

13. Respondent asserted that Complainant waived the right to object to the timeliness of Respondent's filing of Records of Survey and Corner Records because the Board's investigator was in constant contact with the County Recorder regarding respondent's progress in completing outstanding jobs. Respondent argued that Complainant had an extended period of time to object to Respondent's lack of progress but did not do so and that by failing to object, Complainant acquiesced to Respondent's conduct.

While not entirely clear, it appears that Respondent's argument is a modified "laches" defense. Under Respondent's theory, Complainant should be barred from pursuing discipline against him because of the County Surveyor's delay in returning maps to him. As the Court in Fountain Valley Regional Hospital & Medical Center v. Bonta (1999) 75 Cal.App.4th 316, 323 (citing Robert F. Kennedy Medical Center v. Belshe (1996) 13 Cal.4th 748, 760, fn. 9) stated, "[U] nder appropriate circumstances, the defense of laches may operate as a bar to a claim by a public administrative agency . . . if the requirements of unreasonable delay and resulting prejudice are met." The foregoing criteria were not satisfied in this case.

14. Having determining the facts and violations of law, the issue is determining the appropriate discipline that should be imposed.

Complainant established that Respondent had a pattern and practice of not recording maps in a timely manner. Respondent negligently failed to record 41 Records of Survey and negligently failed to file 103 Corner Records. There is no dispute that the County Surveyor's Office had been late in returning maps. However, Respondent permitted many of the maps that were returned to him to languish for many years without activity after they were returned. The County Surveyor took action in an attempt to have Respondent complete and resubmit the maps, without success. Despite the efforts of the County Surveyor, Respondent failed to provide a reasonable time estimate to complete the work he was required to perform. On the date of hearing, Respondent had filed all Corner Records but had 10 outstanding Records of Survey to be recorded. The Board had previously disciplined Respondent. Given the nature and extent of Respondent's wrongdoing, his disciplinary history, his failure to provide a reasonable explanation to support his extended delays in recording documents, the lack of rehabilitation that was established, and the purpose and importance of the recording process, it would be contrary to the public interest to permit Respondent to retain his License. An outright revocation of Respondent's license is the only measure of discipline that is certain to protect the public.

15. Pursuant to Code section 125.3, Complainant seeks recovery of the reasonable costs of investigation and prosecution of \$14,020.

Zuckerman v. State Board of Chiropractic Examiners (2002) 29 Cal.4th 32 held that a regulation imposing costs for investigation and enforcement under California Code of Regulations, title 16, section 317.5 did not violate due process. But, it was incumbent on the Board in that case to exercise discretion to reduce or eliminate cost awards in a manner such that costs imposed did not "deter [licensees] with potentially meritorious claims or defenses from exercising their right to a hearing." The Supreme Court set forth four factors to consider in deciding whether to reduce or eliminate costs: (1) whether the licensee used the hearing process to obtain dismissal of other charges or a reduction in the severity of the discipline imposed; (2) whether the licensee had a "subjective" good faith belief in the merits of his/[her] position; (3) whether the licensee raised a "colorable challenge" to the proposed discipline; and (4) whether the licensee had the financial ability to make payments. The reasoning of *Zuckerman* must be applied to Section 125.3 of the Code since the cost recovery regulation in *Zuckerman* contains substantially the same language as that is set forth in Code section 125.3.

The *Zuckerman* factors have been considered in this case. Respondent genuinely hoped to retain his License. As such, he used the hearing process to obtain reduction of the severity of the penalty Complainant sought. He admitted the violations, but he did not raise a "colorable challenge" to the proposed discipline. He established that his financial ability to pay the Board's costs is limited. Considering the forgoing, after applying the *Zuckerman* criteria in the instant matter, it is reasonable to require Respondent to pay one-half of the Board's costs of investigation and enforcement. Respondent shall pay the Board's costs of investigation and enforcement in the amount of \$7,010.

ORDER

- 1. Land Surveyor License Number L 5280 issued to Paul Christopher Ehe is revoked.
- 2. If Paul Christopher Ehe files a Petition for Reinstatement of his license and if the Board for Professional Engineers, Land Surveyors and Geologists grants the Petition for Reinstatement, prior to reinstatement of his license, Paul Christopher Ehe shall pay to the Board for Professional Engineers, Land Surveyors and Geologists its reasonable costs of investigation and enforcement of this case in the amount of \$7,010.

JURISDICTION

- 3. This Accusation is brought before the Board for Professional Engineers, Land Surveyors, and Geologists ("Board"), Department of Consumer Affairs, under the authority of the following laws. All section references are to the Business and Professions Code unless otherwise indicated.
- 4. Section 118, subdivision (b), of the Code provides that the suspension, expiration, surrender, or cancellation of a license shall not deprive the Board of jurisdiction to proceed with a disciplinary action during the period within which the license may be renewed, restored, reissued or reinstated.
 - 5. Code section 8780 states, in pertinent part:

"The board may, upon its own initiative or upon the receipt of a complaint, investigate the actions of any land surveyor licensed under this chapter or any civil engineer licensed under the provisions of Chapter 7 (commencing with Section 6700) who is legally authorized to practice land surveying and make findings thereon.

"By a majority vote, the board may publicly reprove, suspend for a period not to exceed two years, or revoke the license or certificate of any land surveyor licensed under this chapter or civil engineer licensed under the provisions of Chapter 7 (commencing with Section 6700) who is legally authorized to practice land surveying on any of the following grounds:

"(b) Any negligence or incompetence in his or her practice of land surveying.

"(d) Any violation of any provision of this chapter or of any other law relating to or involving the practice of land surveying."

STATUTORY PROVISIONS

- 6. Code section 8762 states, in pertinent part:
- "(a) Except as provided in subdivision (b), after making a field survey in conformity with the practice of land surveying, the licensed surveyor or licensed civil engineer may file with the county surveyor in the county in which the field survey was made, a record of the survey.

"(b) Notwithstanding subdivision (a), after making a field survey in conformity with the practice of land surveying, the licensed land surveyor or licensed civil engineer shall file with the county surveyor in the county in which the field survey was made a record of the survey relating to land boundaries or property lines, if the field survey discloses any of the following:

- "(1) Material evidence or physical change, which in whole or in part does not appear on any subdivision map, official map, or record of survey previously recorded or properly filed in the office of the county recorder or county surveying department, or map or survey record maintained by the Bureau of Land Management of the United States.
- "(2) A material discrepancy with the information contained in any subdivision map, official map, or record of survey previously recorded or filed in the office of the county recorder or the county surveying department, or any map or survey record maintained by the Bureau of Land Management of the United States. For purposes of this subdivision, a "material discrepancy" is limited to a material discrepancy in the position of points or lines, or in dimensions.
- "(3) Evidence that, by reasonable analysis, might result in materially alternate positions of lines or points, shown on any subdivision map, official map, or record of survey previously recorded or filed in the office of the county recorder or the county surveying department, or any map or survey record maintained by the Bureau of Land Management of the United States.
- "(4) The location, relocation, establishment, reestablishment, or retracement of one or more points or lines not shown on any subdivision map, official map, or record of survey, the positions of which are not ascertainable from an inspection of the subdivision map, official map, or record of survey.
- "(5) The points or lines set during the performance of a field survey of any parcel described in any deed or other instrument of title recorded in the county recorder's office are not shown on any subdivision map, official map, or record of survey.

"(c) The record of survey required to be filed pursuant to this section shall be filed within 90 days after the setting of boundary monuments during the performance of a field survey or within 90 days after completion of a field survey, whichever occurs first.

- "(d) (1) If the 90-day time limit contained in subdivision (c) cannot be complied with for reasons beyond the control of the licensed land surveyor or licensed civil engineer, the 90-day time period shall be extended until the time at which the reasons for delay are eliminated. If the licensed land surveyor or licensed civil engineer cannot comply with the 90-day time limit, he or she shall, prior to the expiration of the 90-day time limit, provide the county surveyor with a letter stating that he or she is unable to comply. The letter shall provide an estimate of the date for completion of the record of survey, the reasons for the delay, and a general statement as to the location of the survey, including the assessor's parcel number or numbers.
- "(2) The licensed land surveyor or licensed civil engineer shall not initially be required to provide specific details of the survey. However, if other surveys at the same location are performed by others which may affect or be affected by the survey, the licensed land surveyor or licensed civil engineer shall then provide information requested by the county surveyor without unreasonable delay.
- "(e) Any record of survey filed with the county surveyor shall, after being examined by him or her, be filed with the county recorder."

7. Code section 8766 states:

- "(a) Within 20 working days after receiving the record of survey, or within the additional time as may be mutually agreed upon by the land surveyor or civil engineer and the county surveyor, the county surveyor shall examine it with respect to all of the following:
- "(1) Its accuracy of mathematical data and substantial compliance with the information required by Section 8764.
 - "(2) Its compliance with Sections 8762.5, 8763, 8764.5, 8771.5, and 8772.
- "(b) The examination pursuant to this section shall not require the licensed land surveyor or registered civil engineer submitting the record of survey to change the methods or procedures

utilized or employed in the performance of the survey, nor shall the examination require a field survey to verify the data shown on the record of survey.

- "(c) Nothing in this section shall limit the county surveyor from including notes expressing opinions regarding the record of survey, or the methods or procedures utilized or employed in the performance of the survey.
- "(d) The examination pursuant to this section shall be performed by, or under the direct supervision of, a licensed land surveyor or registered civil engineer."

8. Code section 8767 states:

"If the county surveyor finds that the record of survey complies with the examination in Section 8766, the county surveyor shall endorse a statement on it of his or her examination, and shall present it to the county recorder for filing. Otherwise the county surveyor shall return it to the person who presented it, together with a written statement of the changes necessary to make it conform to the requirements of Section 8766. The licensed land surveyor or registered civil engineer submitting the record of survey may then make the agreed changes and note those matters which cannot be agreed upon in accordance with the provisions of Section 8768 and shall resubmit the record of survey within 60 days, or within the time as may be mutually agreed upon by the licensed surveyor or registered engineer and the county surveyor, to the county surveyor for filing pursuant to Section 8768."

9. Code section 8773.2 states, in pertinent part:

- "(a) A 'corner record' submitted to the county surveyor or engineer shall be examined by him or her for compliance with subdivision (d) of Section 8765 and Sections 8773, 8773.1, and 8773.4, endorsed with a statement of his or her examination, and filed with the county surveyor or returned to the submitting party within 20 working days after receipt.
- "(b) In the event the submitted 'corner record' fails to comply with the examination criteria of subdivision (a), the county surveyor or engineer shall return it to the person who submitted it together with a written statement of the changes necessary to make it conform to the requirements of subdivision (a). The licensed land surveyor or licensed civil engineer submitting the corner record may then make the agreed changes in compliance with subdivision (a) and note those

matters that cannot be agreed upon in accordance with the provisions of subdivision (c), and shall resubmit the corner record within 60 days, or within the time as may be mutually agreed upon by the licensed land surveyor or licensed civil engineer and the county surveyor, to the county surveyor for filing pursuant to subdivision (c). The county surveyor or engineer shall file the corner record within 10 working days after receipt of the resubmission.

"(c) If the matters appearing on the corner record cannot be agreed upon by the licensed land surveyor or the licensed civil engineer and the county surveyor within 10 working days after the licensed land surveyor or licensed civil engineer resubmits and requests the corner record be filed without further change, an explanation of the differences shall be noted on the corner record and it shall be submitted to and filed by the county surveyor. The licensed land surveyor or licensed civil engineer filing the corner record shall attempt to reach agreement with the county surveyor regarding the language for the explanation of the differences. If they cannot agree on the language explaining the differences, then both shall add a notation on the corner record explaining the differences. The explanation of the differences shall be sufficiently specific to identify the factual basis for the differences."

COST RECOVERY

10. Section 125.3 of the Code provides, in pertinent part, that the Registrar may request the administrative law judge to direct a licentiate found to have committed a violation or violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.

FIRST CAUSE FOR DISCIPLINE

(Failure to Timely Resubmit Records of Survey)

- 11. Respondent is subject to disciplinary action under Code sections 8780, subdivision (d) and 8767 in that Respondent failed to resubmit 41 Records of Survey within sixty days of being returned by the San Bernardino County Surveyor ("County Surveyor") for corrections. THIRD CAUSE FOR DISCIPLINE

(Negligence)

13. Respondent is subject to disciplinary action under Code sections 8780, subdivision (a), 8762, 8767, and 8773.2, subdivision (b) in that Respondent was negligent in the practice of land surveying because: (a) between 1992 and 2009, Respondent failed to complete the map checking process by failing to resubmit 41 Records of Survey within sixty days of being returned by the County Surveyor for corrections; and (b) between 1998 and 2009, Respondent failed to complete the map checking process by failing to resubmit 105 Corner Records within sixty days of being returned by the County Surveyor for corrections. Complainant incorporates by reference Paragraph 11, subparagraphs (a) through (oo), inclusive, and Paragraph 12, subparagraphs (a) through (yyyy), inclusive.

DISCIPLINARY CONSIDERATIONS

- 14. To determine the degree of discipline, if any, to be imposed on Respondent,
 Complainant alleges that on or about September 25, 2000, in a prior disciplinary action entitled In
 the Matter of the Accusation Against Paul Christopher Ehe before the Board for Professional
 Engineers, Land Surveyors, and Geologists, in case number 681-A, Respondent's license was
 revoked but that revocation was stayed and he was placed on four years probation, with certain
 terms and conditions. The facts and circumstances underlying the Decision and Order in case
 number 681-A are that Respondent was negligent and incompetent in the practice of land
 surveying because amongst other things, he failed to file ten required Records of Survey and he
 incorrectly established a common line between two properties. That Decision is now final and is
 incorporated by reference as if fully set forth.
- 15. To determine the degree of discipline, if any, to be imposed on Respondent, Complainant alleges that on or about February 28, 2001, in a prior action, the Board for Professional Engineers, Land Surveyors, and Geologists issued Citation Order 5065-L in the amount of \$2,500.00 to Respondent and ordered Respondent to cease violating Business and

1	Professions Code section 8780, subdivision (b). The grounds for the Citation Order were that	
2	Respondent violated Business and Professions Code section 8780, subdivision (b) because	
3	Respondent negligently removed a monument found while surveying a property. After an	
4	Informal Conference was held, on or about August 16, 2002, the Board for Professional
