Professional Traffic Engineer Application Checklist

Applicants applying for the Professional Traffic Engineer license are encouraged to use this checklist to
ensure that they meet all application requirements.

Confirm that you meet the qualifying experience requirements before applying by reviewing the applicable <u>statutes and regulations</u> , the <u>qualification flowchart</u> and the <u>application instructions</u> . Qualifying experience must be completed by the day of application submission.
Complete the application in its entirety. The application must be typed, and an original/wet signature is required on each page.
Submit a minimum of four (4) <u>Professional Engineer Engagement Record and Reference forms</u> to adequately document that you meet the qualifying experience requirements. Click <u>here</u> for information on what constitutes a satisfactory reference.
Submit official sealed transcripts for all engineering degrees you are claiming for educational credit. Unsealed transcripts are not accepted. Foreign transcripts that are not in English do not need to be sealed, but applicants must submit the original transcripts along with a notarized English translation. Degree evaluations are not accepted.
If licensed as a Professional Engineer in another state, submit a license verification using the verification system available through NCEES. Login to your <u>NCEES</u> account and request that the license verification(s) be sent to the Board.
Submit a copy of your NCEES Fundamentals of Engineering (FE) exam result. Login to your <u>NCEES</u> account and print out the exam result.
Submit proof of completing the fingerprinting requirement, <u>unless you have fulfilled the</u> <u>requirement with a prior application to this Board</u> (i.e. Applicants who have fulfilled the requirement with their California Engineer-in-Training application). Applicants who still need to fulfill the requirement must submit a copy of the completed <u>Live Scan Form</u> (applicants who reside or are currently located in California) or <u>Fingerprint Cards</u> (applicants who reside or are currently located outside of California). For additional information, review the <u>Fingerprinting FAQs</u> .
Submit a completed <u>California Professional Engineers State Laws and Board Rules Exam</u> (Take Home Exam) Answer Sheet. Applicants are required to take and pass this exam to ensure that they are familiar with the laws and regulations that govern the practice.
Submit the appropriate fees as indicated on the first page of the application. Submit <u>one</u> check or money order payable to the Department of Consumer Affairs (DCA).

Put the application, all supporting documentation, and payment in one envelope. <u>Do not</u> submit the documents separately. Submitting the documents separately will significantly delay the processing of your application.
