#### **Executive Officer's Report**

RICHARD B. MOORE, PLS

Welcome to the fall 2021 edition of the Board *Bulletin*. This is the time of year when we publish the latest information on California engineering, land surveying, and geology application volumes, and licensing statistics. In this edition, you will see that volumes for both applications and licenses issued are generally still reflecting a downward trend as a result of the disruption caused by the pandemic. Licensing

numbers reflect that some disciplines of engineering are more popular than in years past, while other engineering, land surveying, and geology licenses are either decreasing or holding relatively steady. We are all hoping that the 2021-22 numbers begin to trend back up as we all rebound from this historic event.

By the time this edition is published, a new release of **BPELSG Connect**, the Board's new online application/licensing portal, will be available. This latest release expands upon previous versions by enabling civil engineer and land surveyor applicants to complete/submit their application online and monitor the status of that application as it moves through the review process. Additionally, this release marks the first time that applicants will be able to submit and pay for a state engineering or land surveying exam at the same time. Once a civil engineer or land surveyor applicant has satisfactorily completed the application process through the technical review stage, a link on the user's dashboard will appear, allowing the applicant to request an exam (or in the case of a civil engineer applicant, two exams) and submit the examination fee online. Upon confirmation of proper submittal and payment, the Board's computer-based testing (CBT) vendor will be notified of the applicant's eligibility and the applicant will receive further notification instructions from Connect for scheduling a seat at one of the vendor's CBT centers around the nation. And after the exam, applicants will receive a notification to log in to their Connect profile to obtain exam results once those are ready.

The Board looks forward to continuing the progress made so far with this new applicant/license management system through the remainder of 2021 and into 2022. Users of the system now receive a link to an online survey after submitting an application or renewing a license for the purposes of providing feedback to the Board relative to how the Connect system is operating. We appreciate and encourage the feedback.

#### Dr. John W. Williams, P.G.



In early August, the Board learned about the passing of Dr. John W. Williams, P.G. Dr. Williams was an active member within the National Association of State Boards of Geology (ASBOG), beginning service in 1995 when the first Council of Examiners Workshop was convened. John served on the ASBOG Executive Committee, becoming president in 1997, and was instrumental in developing and maintaining ASBOG's Committee on Ethics. John also was an active member of the Association of Environmental and Engineering Geologists (AEG), an ASBOG-affiliated

society, serving as president in 1988, and was a founding officer and president of the Engineering Geology Foundation (1996), now the AEG Foundation. He was professor of engineering geology and department chair at San Jose State University from 1976 to 2010, after which he continued to dedicate his energy, time, and extreme intellect to the geologic community.




#### Fundamentals of Engineering (FE) Pass Rates (California vs. National)






#### **Total Licenses Issued Annually, Practice Acts - by Discipline**





#### **Average Number of Licenses Issued Annually Practice Acts**







#### **Average Number of Licenses Issued Annually Title Acts**




#### **Change in Numbers of Active Practice Act Licenses (2011-2021)**













#### **BPELSG Connect User Feedback**

After the initial implementation of the BPELSG Connect portal, staff sought to quantify the experiences of users. The following is a summary of the results:

## Q1. How would you rate your overall experience submitting your application using the BPELSG Connect online platform?

EXCELLENT—71% GOOD—29%

### Q2. Please rank these features in order of importance. (5=Most Important, 1=Least Important)

In order of importance, respondents listed the following:

- Ability to complete application online.
- Receiving text messages from the Board through the portal.
- Ability to pay fees online.
- Ability to view application status online.
- Receiving email messages from the Board through the portal.

## Q3. Compared to your initial expectations, was BPELSG Connect easier or more difficult to use in submitting your application online?

Easier—50% Much Easier—43%

Neutral—7%

### Q4. Did you require assistance from Board staff in completing your application?

No assistance was needed—77%

Some assistance was needed—15%

More assistance was needed than expected—8%

### Q5. Did you contact the Board for a status update on your application?

Yes, I was able to access status updates in the BPELSG Connect portal.—93%

**No**, the platform did not provide enough information regarding application status.—7%

### Q6. Please provide any comments you have that may help us to improve BPELSG Connect.

- 1. Using BPELSG Connect made the application process very easy.
- 2. I had a great experience using the platform. Easy to use, and the available updates on status were helpful.
- 3. Everything went well! Had a bit of confusion on where to send electronic transcript at first, but it was answered by an email to BPELSG Connect.
- 4. Online application process was great. I wish there was a better way to deal with the fingerprint requirement for comity applicants. As a good-standing engineer in Texas who has already submitted fingerprints to the home state, I think this requirement is above and beyond what should be required.
- 5. Would be great to see this method also apply to new PE registration applications.
- 6. 1—There should be some instructions on the Board website that if you do an online application by comity and submit NCEES record, there is no need to get new references and start the process all over again. The website should be able to tell you whether the board received the NCEES record and whether any further action regarding that is needed.
  - **2**—I had one person who was not able to send a reference. Maybe her browser was not supported? She tried multiple times from different browsers, but it never worked.
  - **3**—I was initially told to pay fingerprint fees on top of what I paid online. I told the admin who was handling my case that the paperwork I have says otherwise. Maybe there is a disconnect there as well.
- 7. My references had to do double the work because it was my understanding that I needed to submit by mail at first and then I was required to switch to online-based. I imagine this will not be a problem for future applicants.

#### **Enforcement Actions**

#### Citations Issued to Unlicensed Individuals: Fiscal Year 2020-21 (April-June)

Citations are an alternative to criminal prosecutions that the Board can use to enforce the laws prohibiting the unlicensed practice of engineering, land surveying, geology, and geophysics, or other activities for which a license is required. When a fine is levied with a citation, payment of the fine does not constitute admission of any violations charged but represents a satisfactory resolution of the matter pursuant to Business and Professions Code section 125.9(d). Code sections numbered in the 6700s, 7800s, and 8700s refer to the Business and Professions Code; those numbered in the 400s and 3000s refer to Title 16 of the California Code of Regulations. You can look up the code sections and read the laws on the Board's website, **www.bpelsg.ca.gov/laws/index.shtml**. All final citations are matters of public record. #### Citations Issued to Licensees: Fiscal Year 2020-21 (April-June)

Citations are issued to licensed engineers, land surveyors, geologists, and geophysicists when the severity of a violation may not warrant suspension or revocation of the licensee's right to practice. When a fine is levied with a citation, payment of the fine does not constitute admission of any violations charged but represents a satisfactory resolution of the matter, pursuant to Business and Professions Code section 125.9(d). Code sections numbered in the 6700s, 7800s, and 8700s refer to the Business and Professions Code; those numbered in the 400s and 3000s refer to Title 16 of the California Code of Regulations. You can read the laws on the Board's website, www.bpelsg.ca.gov/laws/index.shtml. All final citations are matters of public record. #### Formal Administrative Disciplinary Decisions: Fiscal Year 2020–21 (April–June)

A formal disciplinary decision is considered formal administrative disciplinary action against a licensee. It results from the Board's adoption of a proposed decision prepared by an administrative law judge following a hearing, a stipulated settlement agreement, or a default decision following a full investigation and the filing of an accusation. An accusation is a formal legal document that notifies a licensee of the Board's charges and allegations of violations against the licensee and that requests a disciplinary order be issued. The licensee is entitled to contest the charges at a formal hearing before an administrative law judge or to agree to a stipulated settlement. A final disciplinary decision contains findings and determinations or statements of advisements, waivers, and culpability and a disciplinary order. If there are findings of violations, the order may include revocation or suspension of the license, a stayed revocation or suspension of the license with a probationary period and terms and conditions of probation, or a public reproval. In the alternative, the decision may find that no violations or violations of a de minimus nature occurred and order the dismissal of the accusation. All final disciplinary decisions are matters of public record.
